Dear Mr Hayes

I am writing to advise you of proposed changes to the Central Sterilising Supply Department (CSSD) Department at Bankstown-Lidcombe Hospital, South-Western Sydney Local Health District (SWSLHD) which has the potential to directly affect your members.

The CSSD department at Bankstown Hospital will be upgraded to meet standard AS5369-2023 and will be closed from November 2024 to 17th (anticipated) to enable the update to occur.

During the period of refurbishment, upgrade, and closure (estimated to be between November and February) the CSSD department will be relocated to a mobile unit on hospital grounds.

The benefits of this temporary relocation will:

- Maintain activities and meet service demand efficiently and timely.
- Minimise risks to patient care and safety, and delays with the reprocessing of equipment used for units such as Operating Theatres and Endoscopy etc.

Due to the upgrade and closure period, it has been identified that the current CSSD operational hours need adjusting and changes are proposed to current shifts to meet service demand due to:

- The smaller footprint of the mobile unit
- Reduced output with a reduction in the reprocessing of equipment resulting with a backlog of
 equipment requiring to be cleared/reprocessed on the evening shift.
- Ensuring adequate space and movement for staff working in a smaller mobile unit resulting in some changes to start and finish times of staff shifts to reduce overlap.
