## PRIMARY PURPOSE

To provide support in the delivery of research services by NSWHP. The research coordinator will work with external and internal clients to determine their needs and NSWHP's role in supporting the research project. The coordinator will facilitate both external, such as a clinical trial, or internal such as a NSWHP investigator led research projects. The role will be responsible for determining the cost of the project and enabling the establishment of the project. In addition, the role will have a primary focus for ensuring all reasonable needs of the clients of NSWHP are always met and that service failures are identified, investigated, and remedied, with appropriate feedback provided to the client.

### RESPIRATOR USE

NSW Health workers may be required to use a respirator, as part of their appointment with NSW Health. Where a respirator is required for use, workers will be instructed in their safe use; including donning, doffing and fit checking. Staff may be required to complete fit testing to selected respirator/s to assess their facial fit/seal.

At all times when a health worker is required to use a respirator, the health worker must not have any facial hair present. Processes are in place to support workers that need to keep facial hair due to religious observance requirements and/ or health conditions.

- Liaise with local health districts (LHDs), other external clients, and research investigators (internal or external) regarding requests for research services
- Work with clients to ensure their reasonable service expectations are met and resolve any queries, risks
  or issues raised in a timely manner.
- Escalate any queries, risks or issues which cannot be resolved in a timely manner to line manager
- Receive, review and action requests for research services in accordance with, or using, approved NSWHP systems, policies and processes and act as the primary NSWHP contact for all queries regarding assigned requests
- Respond to requests for research services in a timely manner, including by preparing and providing quotes based on NSWHP's Statewide Pricing for Research by the required turnaround times (if specified)
- · Where required, populate research agreements for research services using NSWHP-endorsed templates
- Work closely with NSWHP laboratories to ensure laboratory support has been endorsed where required.
- Liaise with NSWHP's Research Governance Office regarding any requests for services that might require site specific assessment and authorisation.
- Ensure the maintenance of accurate records of all proposed and current projects and other work activities.
- Ensure all m onthly reported services are rendered and timely billing of NSWHP services undertaken
- · Travel across the organisation in conjunction with client needs and requirements

- Liaising with a range of stakeholders across NSWHP units, LHDs and other external clients, and multiple
  laboratory information management systems, to ensure the research project is set-up and our facilities
  and people can support research activities and deliver upon research agreements.
