Foreword

Respect for senior Australians is, and must be, a national priority. Out of respect comes all that we value in the care of our ageing loved ones: dignity, quality and safety.

As a nation, these are our goals for the aged care system.

My Government called the Royal Commission into Aged Care Quality and Safety to ensure our oldest and most vulnerable Australians receive care that supports and respects their dignity, and recognises the contribution they have made to society.

The final report of the Royal Commission makes 148 recommendations. Following 23 public hearings over 99 days, 641 witnesses, and over 10,000 public submissions, they are the product of wise and compassionate scrutiny of Australia's aged care system.

We have heard the evidence of senior Australians and their families. It is a call to action. The Government agrees with the Commissioners that strong action is needed for fundamental and ambitious reforms.

The 2021–22 Federal Budget provides a comprehensive response to the Royal Commission's final report. The proposed \$17.7 billion aged care reform package is designed to deliver sustainable quality and safety in home and residential aged care services.

This once-in-a-generation opportunity to confront the inadequacies in aged care will bring real change to the system.

A new Aged Care Act, comprehensive in its scope and depth, will underpin these generational reforms. It will enact our determination to preserve the dignity of life at every stage.

Thank you to everyone who made a submission to the Royal Commission. Thank you for your stories — difficult, personal, sometimes tragic. You told them with courage and insight.

My Government will ensure that you did not tell them in vain.

The Government thanks the Commissioners, the Honourable Tony Pagone QC, Lynelle Briggs AO and the late the Honourable Richard Tracey AM RFD QC, for their tireless work in conducting the Royal Commission, and all those who contributed throughout the course of the inquiry.

- 2. The System Governor should:
 - a. by 1 July 2024, in consultations with representative and peak organisations, complete a national audit evaluating regional and local variation in levels of services for people from diverse backgrounds and life experiences, including consumer experience information, and, in light of the outcomes of the national audit, thereafter undertake commissioning arrangements to address deficits in meeting the needs of people from diverse backgrounds on a regional and local basis as required
 - b. by 31 December 2024, report to the Inspector-General and the public on the extent to which the needs of diverse older people are being met by the aged care system and what further steps need to be taken for the aged care system to meet the needs of diverse older people.

Government Response

The Government accepts this recommendation and is responding through the measures **Residential Aged Care Quality and Safety - Empowering consumers of aged care** with information to exercise choice and Home Care -Connecting senior Australians to aged care services.

The Government will develop a National Aged Care Data Strategy which will identify, improve and better use aged care data to inform current and future service demand, workforce, health interface interaction, quality and safety and outcomes of care, including in the area of diversity.

The Government will expand the education role of advocacy providers to assist aged care providers to understand the diversity of the community they are serving, and assess whether actual usage of their service reflects any barriers to access which must be rectified.

Community Care Finders and assessors will receive training on cultural safety and trauma-informed service delivery.

The Government will also implement a specialisations verification framework and audit process in June 2022 to ensure providers have demonstrated their capability to provide specialised services for people with diverse backgrounds and life experiences.

This may help inform dementia education requirements in undergraduate and postgraduate health care courses.

The Government **accepts** this recommendation and is responding through the measure **Workforce - Growing a skilled, high-quality workforce to care for older Australians.** This builds on a number of programs announced in the 2020-21 Budget.

Initiatives include:

- For nurses, the Aged Care Transition to Practice Program will attract and retain newly graduated registered nurses into aged care, and a scholarship program will support postgraduate qualifications for nurses.
- The Home Care Workforce Support Program will provide training and facilitate work placements for vocational education and training students to become personal care workers in the home care sector.
- A bonus payment will be made available to nurses who take on responsibility for work and clinical placements for aged care students.
- The Rural Health Multidisciplinary Training Program infrastructure included projects in aged care services to provide dedicated teaching spaces and partnerships with one or more University Departments of Rural Health to manage the training of nursing and allied health students.
