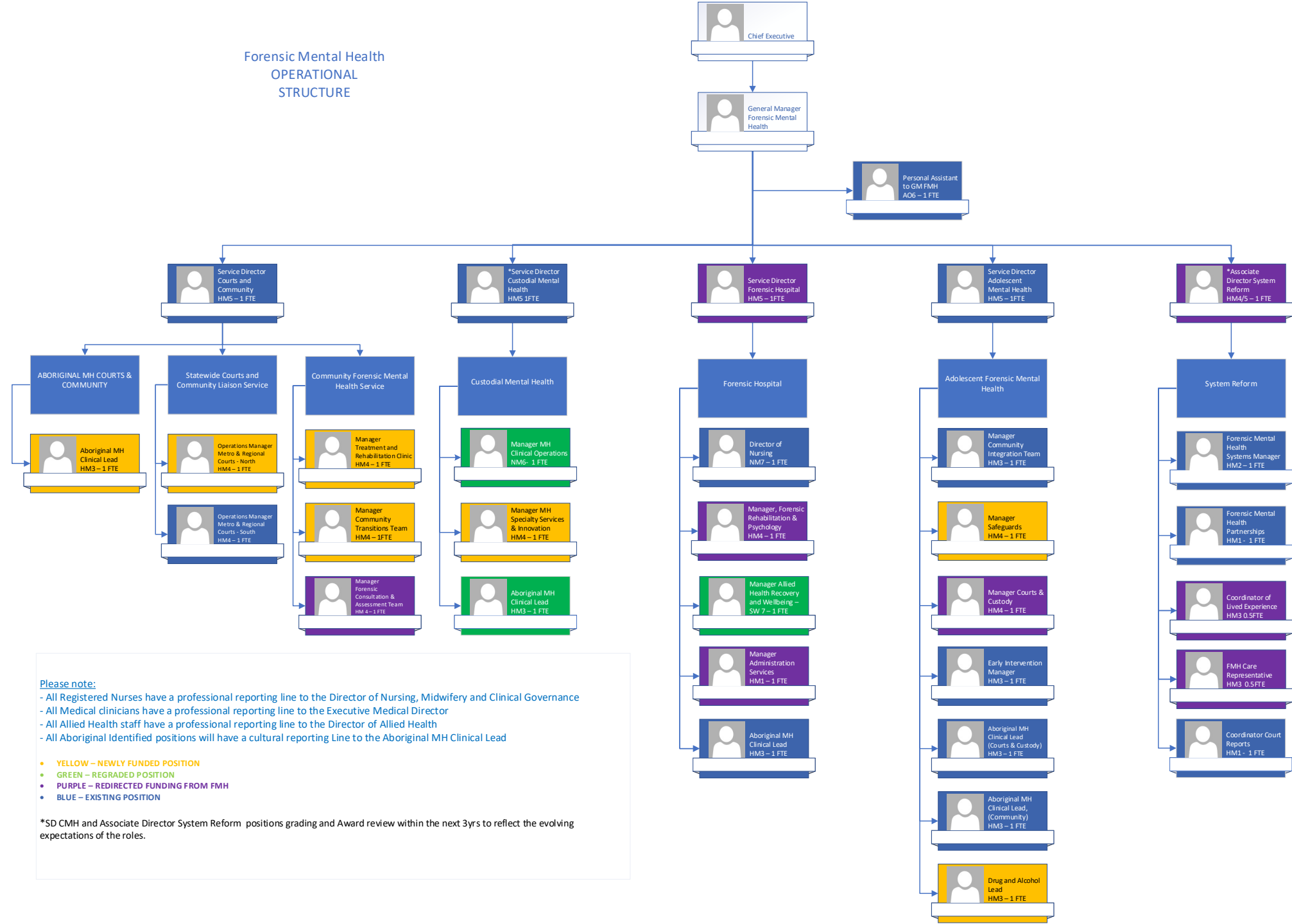

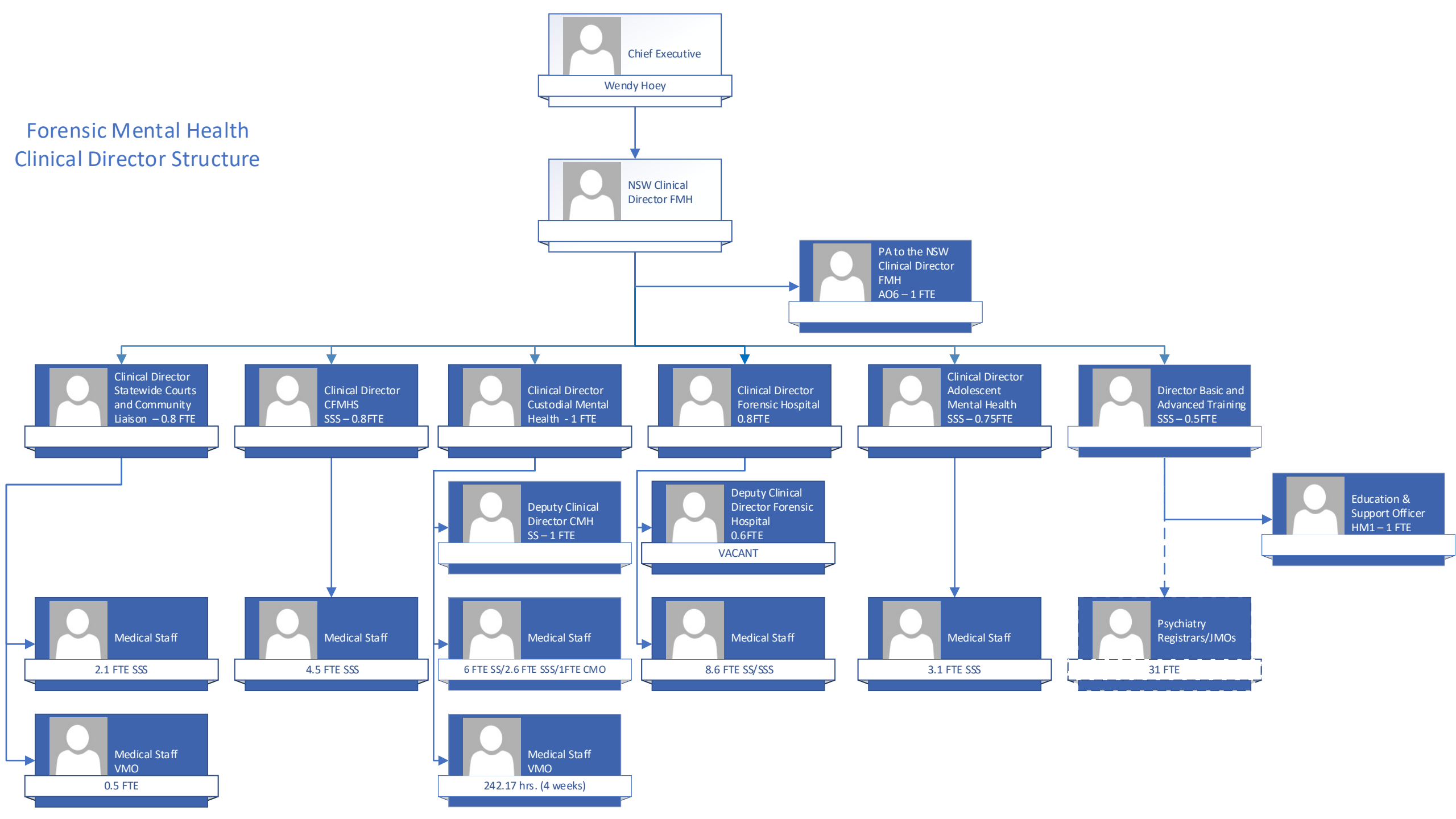

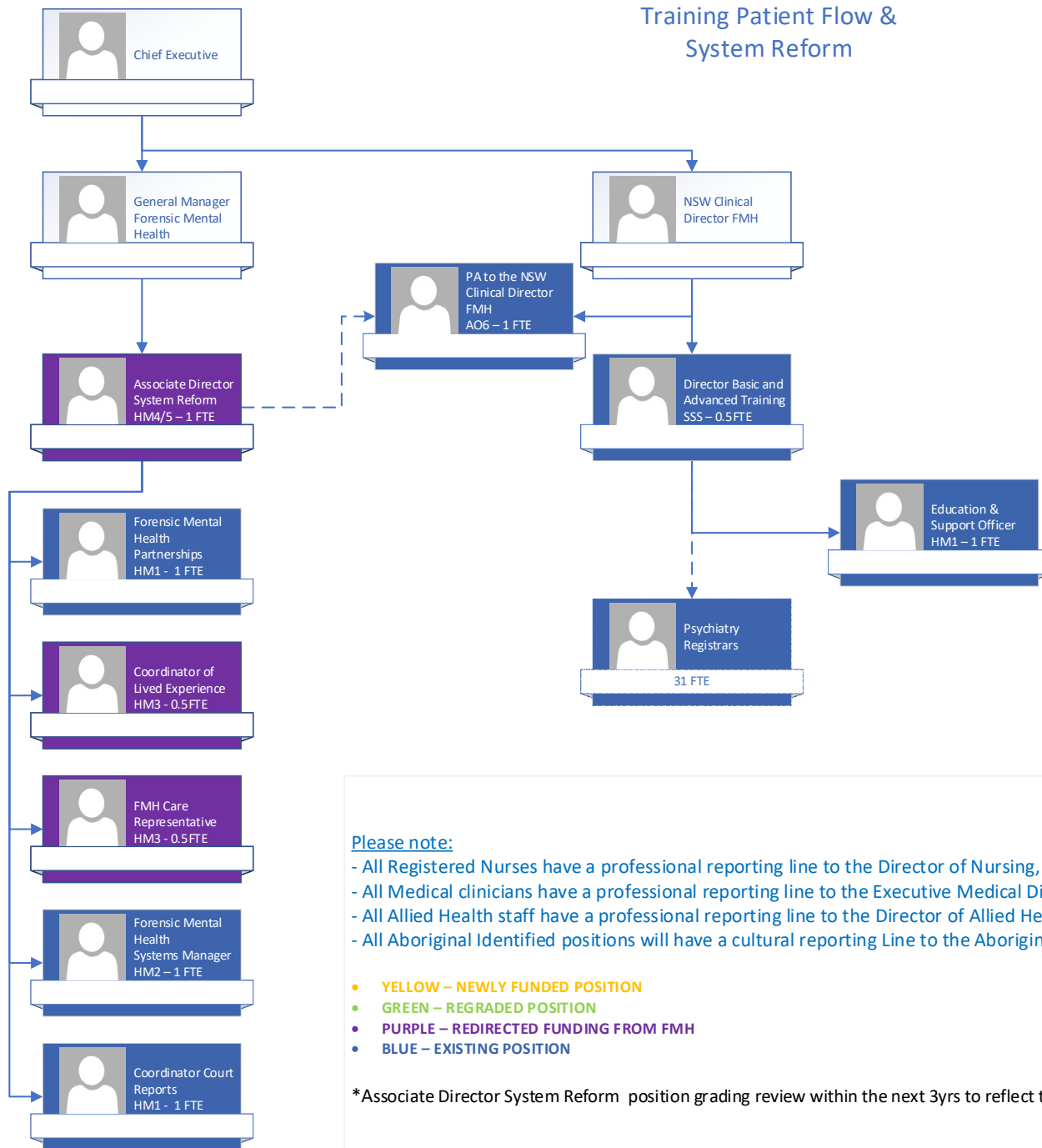

Training Patient Flow & System Reform



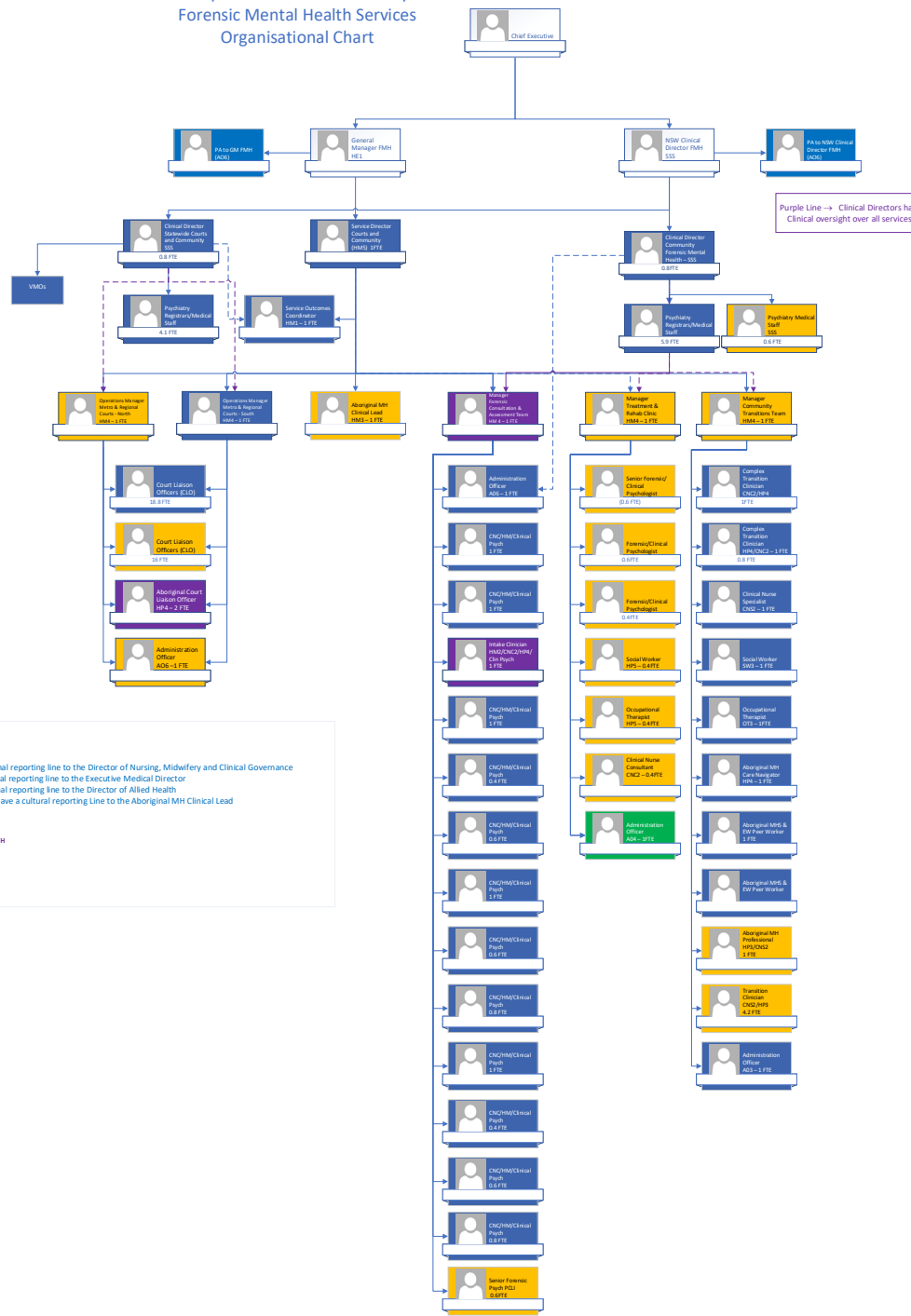

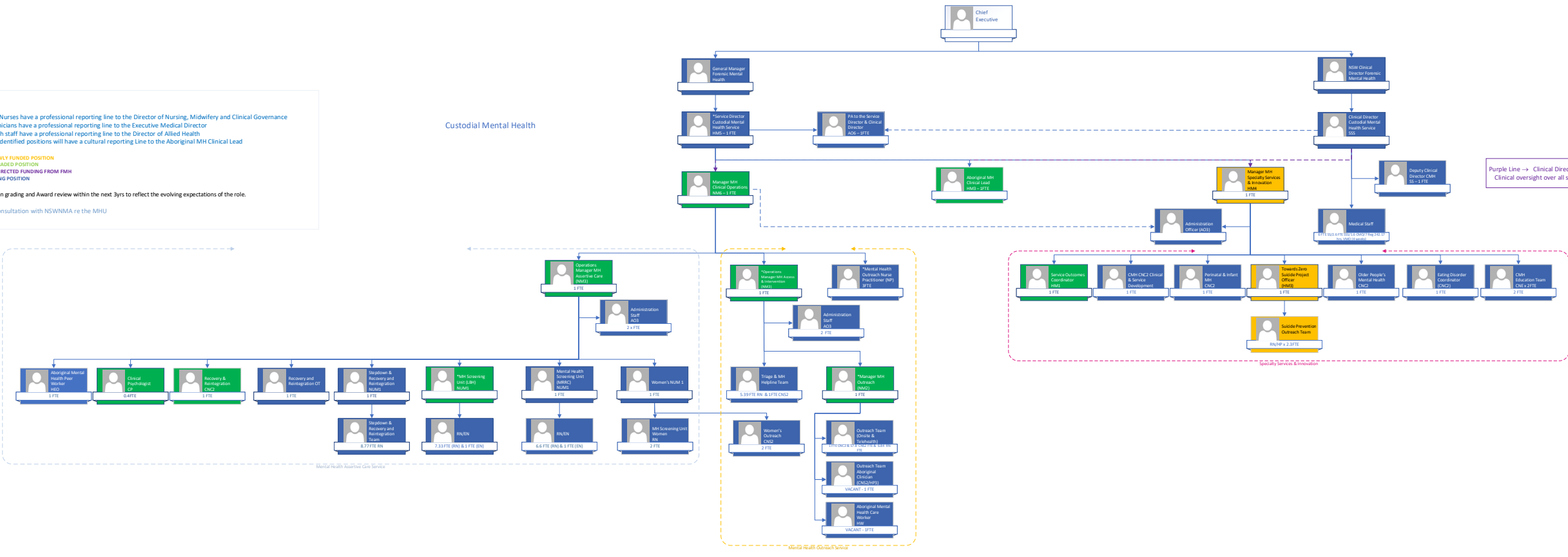

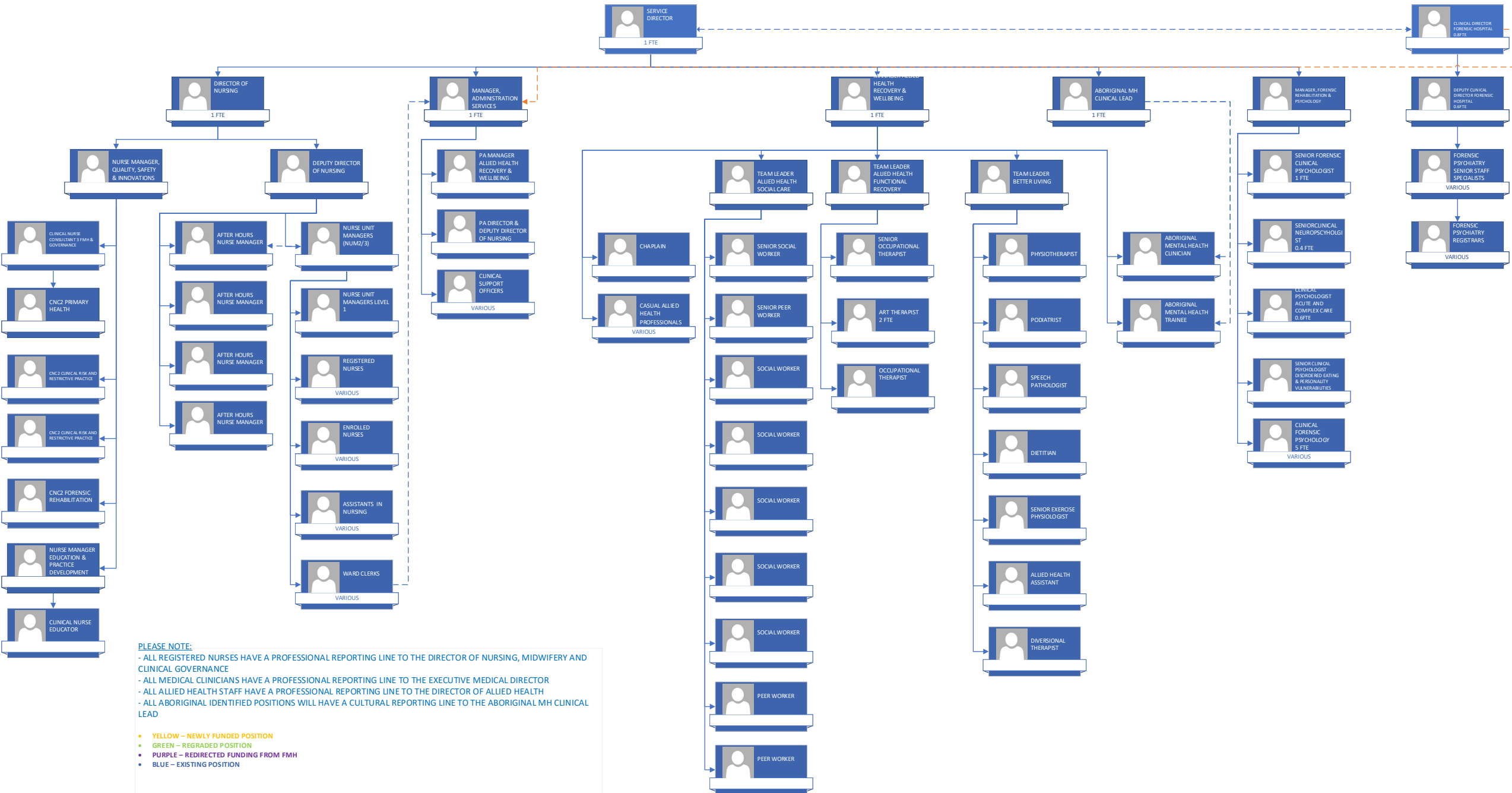
