Private use of Motor Vehicles

Dear Gerard

I am writing to you about proposed changes to the charges for the private use of motor vehicles provided for in NSW Health Information Bulletin 2015_013 Motor Vehicle – Award Employees – Charges for Private Use ('current rates') as required by NSW Health Policy Directive 2023_030 NSW Health Vehicle Procurement and Use ('charging policy').

Since 2008, the charges have been based on the Senior Executive running costs for a large standard vehicle. The current rates were last changed in 2015 as outlined in IB 2015_013.

A review of the current charges has identified that the rates are no longer appropriate and no longer satisfy their intended use with associated FBT liability across the State. The Australian Taxation Office (ATO) transitioned from using the non-rotary engine rate methodology for vehicles expenses from 1 July 2015 which further supports that current rates are outdated.

To ensure rates are in line with current running and standing costs, together with the introduction of separate charges for electric vehicles, new rates are proposed from 1 January 2025.

The new rates set out below are based on the cost price of the vehicle and the private use percentage elected by the employee, together with an estimated running cost of common vehicle within the various cost price group. The running costs are aligned to NSW Treasury's guidance on Salary Packaging Motor Vehicle Costs for 2023-24.

Running costs are based on NSW Treasury Salary Packaging Motor Vehicle Costs Guide for 2023-24. Estimated lease costs of common vehicles within the various cost price groups, and new electric vehicle groups were provided by NSW Health fleet provider to provide current indication of the market.
