Re: North West Cancer Centre - Proposed Change to Rostered Hours Radiation Oncology Department

I write in relation to a proposal to change the Rostered Hours for the North West Cancer Centre (NWCC) Radiation Oncology Department located at Tamworth Hospital.

The Radiation Oncology Department provides essential radiotherapy treatment, a valued and critical clinical service for patients in our community requiring this type of cancer treatment. To ensure maximum availability of this service to patients it is proposed to extend the treatment day by two hours per day. It is also proposed to operate the equipment for two to three hours on alternate Fridays to better suit the needs of patients requiring hypo-fractionated courses of treatment.

To support the change in treatment hours from 8am – 4pm, to 7.30am – 5.30pm and some treatment on alternate Friday mornings, the following changes to the Rostered Hours are proposed:

Staff consultation has occurred in relation to the proposed changes to the Roster, including a whole of Department meeting with staff on 22 October 2024.

Additional staff resourcing has been funded and recruited to extend the hours of operation of the department. This included 4 FTE additional radiation therapists including 1 FTE Senior Radiation Therapist, 0.26 Registered Nurse and 0.14 Administration Officer.

The changes are planned to commence from 1 January 2025. We would like to move forward with the proposal as soon as possible, and your response would be appreciated by Friday 16th November 2024.
