Dear Mr Hayes,

I wish to advise the Health Services Union (HSU) of a proposed realignment of Security Services including internal reporting structures of Macquarie Hospital, Mental Health Drug and Alcohol (MHDA) within Northern Sydney Local Health District (NSLHD).

Following a realignment of the Macquarie Hospital Executive Team earlier during 2024, it has been identified that the role of Operations Manager now has capacity to focus more wholly on the site wide corporate services functions of the Hospital.

Additionally, the recently increased Security Manger position, which is now a permanent full time role provides an opportunity to consider a realignment for the Security Services. The proposed changes will also align with the Northern Sydney Local Health District model of Security Services reporting through the corporate services structure.

The attached Consultation Document and Position Descriptions provide more details on the proposed reporting line and organisational structure changes.

This letter marks the commencement of a formal three-week consultation period. I invite you to provide any feedback, comment, questions, or concerns on this proposal. The consultation period will conclude three weeks from the date of this letter.
